HELPFUL TIPS FOR CHOOSING GODPARENTS

Having made the decision to have your child baptized, you are now faced with another decision; the choice of your child's godparents. A godparent is not simply a witness on the day of the Baptism or a good example of virtue, but someone you want in your child's life to help in imparting the faith to your child. Inviting someone to be a godparent is:

- A request by the parents for the assistance of the Christian community, particularly the individual godparents, in raising their child in the Catholic faith.
- An affirmation of the Catholic faith of the individuals invited to be godparents and a challenge to them to witness their faith.
- A statement by the parents that they want their child to be positively influenced by the faith and lives of the people they have invited.
- A reminder of the entire community that is has shared responsibility to support each of its members.

The child must have a least one Catholic godparent. If you wish, you may choose two, one male and one female. The person chosen should:

- Be mature enough to carry out the responsibilities of godparents (age 16 years or older)
- Be someone who is committed the Catholic faith, regularly attending Sunday Mass and giving witness to the Gospel in everyday life.
- Be willing to profess the Catholic faith with the parents immediately before the actual pouring of baptismal water and should have no reservations about doing so.
- Have received the sacraments of Baptism, Confirmation and Eucharist
- Be willing, in whatever way he or she can, to cooperate actively with the parents in helping the being the child up as a Catholic.

For obvious reasons, only a member of the Catholic Church (or Easter Orthodox Church) may be a godparent. Members of non-Catholic communities, although they may be very good Christians, do not share sufficiently in our belief to the committed to raising the child in all the truths of the Catholic faith.

Parents choose godparents for a variety of reasons; however, the spiritual welfare of your child should be the only motivating factor for your choice of godparents.
